1. The last date for submission of sealed tender in the office of the Principal, **J.N.V. Trapaj Bunglow By Hand or through Regd. Post will be 17-06-2019 up to 05.00 PM. Tenders received then after will not be accepted and rejected.**
2. The Vidyalyaya is having 03 Nos. of Water RO System, All the above machines are to be covered under Annual Maintenance Contract.
3. The rate of contract shall be including of all the levied taxes applicable if any as per the ST/GST/CST /VAT act.
4. The maintenance work should be made in the site only and permission will not be given to carry out the parts outside the Vidyalyaya campus.
5. The rate with change of parts and without change of parts should be given separately in the tender.

6. The parts which will not be in the working condition and to be replaced with new one will be deposited back in the Vidyalaya.
7. No extra payment will be made beyond the contract agreement at any cost.
8. All the parts to be replaced in the RO system are as per the required brand/ specification of the ISI and as per the recommendation of the manufacturing unit of the system. Duplicate parts / inferior quality of the parts will not be accepted and payment thereof will not be released. Apart from this, the E.M.D./S.D. will be forfeited in such case.
9. All the RO system will throughout clean up once in a month.
10. All the RO system will have to check and service once in 15 days failing which penalty @ Rs. 100-00 per system per day which will not functioning will be deducted from the bill without assigning any reason.
11. The due date for servicing of all the systems are 01 & 15 of each month.
12. The minor repair like setting of the ro, will cover under the minor work of AMC and no extra payment will be released thereof.
13. The tenderer should submit the complete servicing / repairing report to the Principal of Vidyalaya in duplicate and must have to obtain signature of the Ro Incharge of the Vidyalaya.
14. As far as possible, weight age may be given to repair the non working parts instead of replacement.
15. No transportation / conveyance or visit charges will be paid while the engineer visits the Vidyalaya for maintenance.
16. Cutting, overwriting in the tenders will not be accepted and such tender(s) will be rejected.
17. The tenderer should fill in the rates in the format of tender form only and conditional tender will not be accepted.
19. Acceptance of the tender in whole or part will be the decision of the PAC.
20. Amount equal to the 10% of the contract value will be deposited as security deposit and will be refunded after successful expiry of the contract period.
21. The bidder should inspect the ro systems etc. before quoting the rates and no request will be entertained after initiating the AMC.

In case of successful bidding, this amount will be adjusted in the S.D. and rest of the amount of S.D. as per contract value will have to be deposited by the bidder at the time of signing of contract agreement.
25. Incomplete and unsigned quotation will be rejected.
26. Payment will be released on quarterly basis.
27. **The contract will be valid up to 30-04-2020 and the rate may please be filled in for ten months from July 2019 to April 2020 (i.e. for 10 months.).**
28. In case of any dispute arise; the decision of the PAC will be the final.
29. In case of failing to maintain the terms and condition by the bidder, the PAC will have the full power to cancel the contract in mid between the contract periods.
